- 1. Please provide a short, executive summary outlining your proposal, clarifying why the program/field is needed, and identifying mitigation measures for any negative or unexpected consequences of your proposal.
- 2. Explain anticipated impacts, if any, associated with the <u>Graduate Faculty's Code of Legislation</u>, including:
 - a. Appointment of the DGS (if applicable)
 - b. Nomination of faculty as field members (if applicable)
 - c. Student selection of Special Committee (chair and two minor members; will there be a field-appointed member?)
 - d. Timing, format of, and expectations for the A Exam (for PhD programs)
 - e. Will students be eligible for a master's degree upon completion of the A Exam? (for PhD programs)
 - f. Number of registration units required for the degree
- 3. What are the sources and amount of funding for students?
 - a. If this is a professional program, will any funding be made available to support students with financial hardship or promote diversity?

- b. If this is a doctoral program, what is the anticipated funding duration and typical pattern of funding?
- 4. How will admissions decision will be made? Share evaluation rubrics, if available (this can be an appendix if it exceeds the 5-page limit).
- 5. Describe how course evaluations and/or periodic external reviews will be used to support program improvement.
- 6. What are your plans and resources for recruitment, mentoring, and creating a culture of belonging for students from diverse backgrounds?
- 7. What are your plans and resources to support the professional development of students in the proposed program? For master's degree programs, will career services be offered by the program, college, or coordinated centrally by the University Career Services office?
- 8. What are your plans and resources to create a culture that supports the mental health and well-being of students in the proposed program?
- 9. List other Cornell degree programs or concentrations that overlap or are closely related to the proposed program. What are the distinctive elements of the proposed degree program?
- 10. Demonstrate you have vetted the name and disciplinary focus and provide statements or letters of support from programs with similar names or disciplinary overlap (letters not included in page limit).
